1 EXECUTIVE SUMMARY

Question 1: Summary of progress achieved during the reporting period.

The main outputs of EUSDR Priority Area 4 (PA4) "Maintain and restore the quality of waters" was to coordinate and manage the implementation of the PA4 targets elaborated in detail into 14 activities of action plan (Roadmap) with the aim to contribute to the improvement of water quality in the Danube Region. The main activities are focused on supporting the protection of water resources, assistance in the implementation of EU Water Framework Directive (WFD) and the Urban Waste Water Treatment Directive (UWWTD), improvement of fish migration, addressing the water issues related to climate change impacts, promotion of measures addressing agricultural pollution, facilitation of sub-basin activities. PA4 provided assistance in project generation, partnership search, networking, alignment of project funding, dissemination.

PA4 team deepened synergies and strengthened cooperation with international organizations, signed Memorandum of Cooperation between the Carpathian Convention (CC) and the EUSDR, PA4 (Annex 1), actively participated at CC and ICPDR events.

Moreover, PA4 was concentrating on **new project preparation** and assisting in setting up project consortia, two **project proposals, strategically important for PA 4,** were adopted by DTP 1st call for funding - **JOINTISZA** and **DANUBE SEDIMENT.**

PA4 team continued to **implement Road map activities** in accordance with the topics of the Slovak EUSDR Presidency - organized the international **workshop** "Trust-building between Water and Agriculture Sectors in the Danube Region" in Bratislava on 04/10/2016 (see link http://www.danubewaterquality.eu/news/workshop-trust-building-between-water-and-agriculture-sectors-in-the-danube-region); participated in the workshop "Water and agriculture" organized within the Slovak Presidency in the Council of the European Union on 24/10/2016 in Bratislava and workshop titled "Water – non-alternative source for life" (see the following link - http://www.danubewaterquality.eu/news/5th-eusdr-annual-forum) during the 5th EUSDR Annual Forum. PA 4 helped to organize Budapest Water Summit held on 28-30/11/2016 within which the Stakeholder Seminar took place.

PA4 prolonged the **cooperation Non-EU countries** in Solotvyno, Ukraine and **other Priority Areas** within Pillar B (PA4-PA5-PA6); PA10 and PA7.

To coordinate PA4 effectively, namely its Roadmap activities and managing priority area, PA 4 team participated at the Danube Transnational Program PAC seminar and Danube Strategy Point Consultation meeting with the EUSDR Priority Area Coordinators (09/2016, Budapest) and EUSDR Consultancy Group meeting (07/2016, Bratislava). PA4 organised the Trilateral working group meeting among PA4 SK-HU, ICPDR and Sava Commission on 9/9/2016 in Budapest (Annex 2), Stakeholder meeting (21/11/2016, Bratislava) and 12th PA4 Steering Group Meeting (1/12/2016, Budapest) (Annex 3) where PA4 Seed Money facility (SMF) priorities were adopted.

The project proposal comprised the PA4 work plan for the period 2017-2019 was submitted within Danube Transnational Programme, Specific Objective 4.2 Support to the governance and implementation of EUSDR.

The visibility of PA 4 and dissemination of its achievements is ensured via continuous update of PA4 website www.danubewaterquality.eu. The achievements and plans of the priority area were presented at the Slovak National Participation Day (21/10/2016, Bratislava). The brochure "What is new in the update Water Directive?" **Drinking** was issued in October 2016 Moreover, http://www.danubewaterquality.eu/uploads/files/Drinking_Water_cela_web.pdf. the information on conference and workshop organised by PA4 were published in Water Management Journals 7-8 /2016 (Annex 4) and 11-12 /2016 (Annex 5), in Slovak.

2 PROGRESS OF THE PA

2.1 PROGRESS ON POLICY LEVEL

2.1.1 POLICY AREAS AT FOCUS

Question 2: What are the policy areas (important policy topics/thematic issues) that the PA selected as main focus (i.e. priority) for work during the reporting period?

Cooperation with ICPDR and ICPDR Tisza Group especially in river basin management planning process, strengtheningsub-basin cooperation: Tisza, Sava, Prut, Danube delta, awareness raising, synergies, NON-EU cooperation.

Moreover, cooperation with the Carpathian Convention in joint projects and synergy activities and topics as climate change, water resources protection and others.

Cooperation with the Sava Commission in joint projects and synergy activities.

Question 3: What are the main arguments for selecting those policy areas as priority ones?

ICPDR-EUSDR PA4 and PA5 coordination – signed Joint Paper on Cooperation and Synergy for the EUSDR Implementation.

Signed Memorandum of Cooperation between Carpathian Convention and EUSDR, PA4 "To restore and maintain the quality of waters"

Sava Commission – common sphere of interest – geographical area – brought mutual benefit.

2.1.3 POLICY LESSONS LEARNED

- Mutual cooperation between ICPDR and Sava Commission resulted in mutual benefits;
- Closer cooperation with Carpathian Convention based on Memorandum signed;
- Widespread dissemination activities are fostering the strengthened cooperation with regional
 organisations and international organisations (JRC, GWP) as well as commencing new connections
 with EIP Water and the OECD;
- The successful workshop "Trust-building between Water and Agriculture Sectors in the Danube Region" presented synergic aims with the workshop "Water and agriculture" organized within Slovak Presidency in the Council of the European Union. The outcomes of this workshop were brought to the attention of Water Directors at their meeting on 28-29 November 2016, with the aim to get a mandate to organize a joint meeting of Water Directors and Agriculture Directors in the spring 2017.

Question 7: Based on the information provided in Table 1, what is the PAs overall self-evaluation with regards to reaching the applicable targets? Any other positive experience or other important information to that respect that the PA considers necessary (or good) to be shared should be included here as well.

Several activities and tasks have been achieved in previous period, especially related to the implementation of Roadmap Action 4 (Assessment of financial needs of the Danube countries for the implementation program on building and updating UWWT technology) and Action 11 (Dissemination and integration of results of the best practices and policies for decision-makers and stakeholders into the Risk assessment and 2nd DRBMP – updated to current conditions the issues on drought and water scarcity).

Within this reporting period there was implemented the Roadmap Action 6 (Strengthening the cooperation between agriculture and water authorities) and Action 13 (Promotion of dissemination of guidelines concerning the safeguarding of drinking water supply).

However still many tasks are yet to be completed asPA4 has 14 actions including 63 milestones and PA4 continuously work on their implementation.

Question 8: What, if anything, was/is missing in order to achieve the progress in reaching the targets as previously planned?

PA4 is working jointly with the ICPDR and Sava Commission to reach the targets. For their successful completion necessary funds need to be explored and further utilized by PA4.

Question 9: Are there any plans (or needs) for revising/updating the list of targets, applicable for the PA? If so, please provide details.

No. The revision of targets were discussed and adopted by the SG in the previous reporting period. SG decided that only a timeline is to be modified related to Target 3. The new revised EUSDR Targets, including for PA4 were adopted by the EUSDR National Coordinators and Commission on 23 May 2016 in Bratislava at the joint NC/PAC Meeting. Therefore no further modifications are applicable to PA4.

Question 10: Based on the information provided in Table 2, what is the PA's overall self - evaluation regarding the progress in implementing the actions? A positive experience or other important information to that respect that the PA considers necessary (or good) to be shared should be included here as well.

PA4 has reached significant progress in the implementation of the targeted actions. Steps have been done in case of all actions, however, taken into account that most of the actions include several milestones, which have long term implementation period. Some actions (Action 1) can be considered finalised in the frame of adoption 2nd DRBMP, but the action is ongoing in its implementation. The Joint cooperation with the ICPDR, Sava Commission and other relevant international organisations has also facilitated the development of the tasks and PA4 could avoid duplication of work. The harmonisation of the common tasks with relevant international organisations was also encouraged and appreciated by the experts, working in these processes (e.g. in ICPDR, Sava Commission and EUSDR).

To strengthen cooperation with international bodies, the Memorandum of Cooperation between Carpathian Convention and PA4 EUSDR was signed. The remarkable achievements were reached not only in the field of coordination and projects preparation, but the roadmap actions implementation in this reporting period – see Chapter 2,5

Question 11: What, if anything, was/is missing in order to achieve the progress in implementing the actions as previously planned?

The previous funding of EUSDR concentrated on managing and coordination financing did not provide wide possibilities for project funding. Therefore, the newly established Danube Transnational Programme (DTP) as well as other financial opportunities offer good possibilities to accelerate the implementation process, especially Roadmap actions implementation. DTP provides visible links to EUSDR priorities and tries practically to embed the strategy into the programme. In 2015-2016 PA4 has supported the development of two proposals for PA4 relevant projects in the subject of sediment issues and Tisza sub-basin cooperation, which were adopted for financing from DTP and are fully linked to the PA4 Roadmap.

The problem of all PAs is the low attendance of SG members at SG meetings. Moreover, the low involvement of SG members is reflected in feedback to the activities performed by PAC4 teams. One of the possibilities to enhance the attendance of SG members in SG meetings could be the NCPs involvement of all Danube states to motivate their SG members to participate at SG meetings of particular priority areas.

Question 12: Are there any plans (or needs) for revising/updating the actions, applicable for the PA? If so, please provide details.

The PA4 Roadmap actions and milestones were revised in cooperation with ICPDR in autumn 2016 and then adopted by PA4 SG members. Subsequently, the updated version was provided to DTP as the Annex to PA4 action plan for the upcoming period (2017-2019). For these reasons we do not predict the update/revision of PA4 actions in upcoming period.

Question 13: Based on the information provided in Table, what is the PAs overall self - evaluation regarding the progress in reaching the milestones? A positive experience or other important information to that the PA considers necessary (or as good) to be shared should be included here as well

Out of the 66 milestones specified by PA4 experts up to 2016, almost one third have been completed (20). That is more than satisfactory, because many of the milestones are ongoing, partly reached, and prolonged to upcoming period, although there were made significant steps forward. The implementation of the actions via organisation of events for dissemination experts' knowledge, looking for new solutions, facilitating financing possibilities, fostering projects generation does not mean in this viewpoint the finalising of the milestones, only the way of proceeding.

Question 14: What, if anything, was/is missing in order to achieve the progress in reaching the milestones as previously planned?

The implementation of the milestones was slowed down in 2012-2015, since no suitable funds for the implementation were available. The newly available funds via the Danube Transnational Programme as well as other financial opportunities offer good options to accelerate the implementation process. For instance, in 2015-2016 PA4 supported the development of two proposals forPA4 relevant projects – JoinTisza and Danube Sediments – which were adopted for financing within DTP 1st call. The aims of the projects are fully coherent with PA4 Roadmap.

3 Funding

3.1 MAIN ACHIEVEMENTS IN TERMS OF FUNDING

Question 16: What is considered as PAs main achievement/s with regards to funding sources and opportunities for EUSDR projects? Short analysis relevant only to the duration of the reporting period needs to be provided.

PA4team organised the 3rdStakeholder Seminar within the Budapest Water Summit on 30 November 2016, in Budapest. The aim of the seminar was to provide an overview about the water-related Priority Areas (priority area on 'water quality' and 'environmental risks'), to present the results achieved and to provide detailed information about funding instruments from central funds to specific territorial cooperation instruments. Furthermore, the seminar offered a possibility for partner search, presented country needs and assisted in the alignment of funding procedure for future project beneficiaries by promoting further project ideas.

To promote the setting up of project consortia, PA4 facilitated to setup JOINTISZA project consortium as well as strongly contributed to sub-basin cooperation via Tisza Office that originated in April 2016 in Szolnok.

Moreover, PA4team participated actively in DANUBE SEDIMENT project proposal.

Both projects which are considered to be relevant and "strategic" for PA4 were adopted for financing within the 1st call of DTP. PA4 is honoured that two relevant PA4 projects passed through in very high competition of the projects in DTP 1st call.

PA4supports the new project ideas in cooperation with ICPDR such as DanubeFloodplain and Danube Sturgeon. The projects are supposed to be submitted in upcoming DTP call.

3.2 LESSONS LEARNED

Question 17: What are the lessons learned (positive or negative) during the reporting period, with regards to funding sources and opportunities for EUSDR projects and what responses to those the PA considers as relevant?

- With regard to the water pollution from agriculture the PA4 reached success in bringing together and starting the dialogue between water and agricultural sectors. The successful international workshop was organised with the title "Trust-building between Water and Agriculture Sectors in the Danube Region". The topic was important for Slovak Presidency in EUSDR as well as for the Slovak Presidency in the Council of the European Union, so the workshop was followed up by the event "Water and Agriculture" organized by MoE SR.
- The topic of agriculture and water cooperation is important for the upcoming period where ICPDR will prepare the guidance document in this regard. PA4 plans to cooperate with ICPDR on this topic in the future.
- Successful project development procedures (two proposals for projects of strategic importance to PA4 were adopted by the DTP for financing, such as the JOINTISZA and DANUBESEDIMENT. The project ideas will further strengthen basin wide and sub basin wide activities as well as cooperation among relevant international and regional organisations.
- Participation on preparation of new project proposal planned to be submitted in the upcoming DTP call
 Danube Floodplain and Danube Sturgeon.
- Dissemination of PA4 achievement and plans at PA4 website www.danubewaterquality.eu and other relevant events (for instance Danube Participation day)
- Printing the brochure on information "What is new in the update of Drinking Water directive?"

3.3 THE FUTURE

Question 18:Based on what has been reported so far in Sections 3.1 and 3.2, what next steps and challenges in terms of funding sources and opportunities for EUSDR projects that are important to be shared for further consideration, discussion or development(incl. possible solutions to overcome the challenges)?

Please answer also the same question with respect to better alignment of funding to support the PA and the EUSDR in general.

With regard to PA4 coordination financing, PA4 successfully submitted the project on PA4 work plan for 2017-2019 with the Specific Objective 4.2 Support to the governance and implementation of EUSDR of Danube Transnational Programme. The project was approved and at present it is under administration process of the contract signing.

The two proposals for projects of strategic importance to PA4 were adopted by the DTP for financing - JOINTISZA and DANUBE SEDIMENT. The project ideas will further strengthen basin wide and sub basin wide activities as well as cooperation of relevant international and regional organisations. PA4 strongly support these projects implementation which are in close connection to PA4 Roadmap actions implementation.

Moreover, PA4 clearlyparticipated in cooperation with ICPDR and other Danube region partners in preparation of new project proposal planned to be submitted in the upcoming DTP call – Danube Floodplain and Danube Sturgeon. PA4 is also participating in the development of the REVISTRUR project proposal, which objectives are strongly linked to target 4 of PA4.

PA4 teams regularly inform the SG membersand EUSDR stakeholders about the possibilities of project funding from various EU funds (LIFE, Central Europe, Horizon 2020, DTP, Danube Strategic Project Fund etc.) and try to connect them in various types of cooperation, so called project networking.

PA4 will further develop and facilitate new project proposals and concentrate on its flagship/strategic projects. PA4 supports continuously to set up new project ideas, createconsortia and facilitate partners search within the programs mentioned above.

Priority area 4 will carry on activities in relation to the submitted project proposals and case no funds are secured PA4 will organise follow-up actions to make sure that the targeted issues are supported with funds.

Furthermore, PA4 will continue organizing stakeholder seminars concerning funding possibilities and will encourage further networking among possible project partners for the sake of setting up further project consortia.

Moreover, PA4 will continue its concentration on non-EU countries cooperation, mainly in the field of waste water treatment and drinking water supply.

4 GOVERNANCE

4.1 ORGANISATION AND FUNCTIONING OF PA

No changes occurred since the last Annual Report.

The PA has a **tripartite governance**ensuring wide spectrum of the development of the actions: the Hungarian and the Slovakian Priority Area Coordinators (PACs) and the International Commission for the Protection of the Danube River (ICPDR). Beside these three actors also the International Sava River Basin Commission, (i.e. Sava Commission - ISRBC) plays an important role for the PA4.

The Priority Area Coordinators are Mr László Dr Perger, Chief Advisor of the Directorate General of Water Management, Hungary and Mr Vladimír Novák, Director General of the Water Section from the Ministry

of Environment of the Slovak Republic. The joint work between EUSDR and ICPDR has been facilitated via joint meetings, so called Trilateral meetings, held twice a year and by signing the memorandum on synergies between EUSDR PA4 and PA5 and ICPDR.

The **Steering Group** of PA4 meets twice a year. For better and more effective coordination and more over for saving money, as well, the PAC coordinators strive to organize back-to back meetings with ICPDR and cover the participation of SG members from non-EU countries.

4.2 COORDINATION AND COOPERATION ACTIVITIES

Question 21: Based on what has been reported in Section 0, please provide short description on what has been achieved with theundertaken activities for coordination, cooperation and establishing links with other PAs? Please describe also any methods/tools that are put in place as a result (if applicable).

PA4 strongly supported the cooperation with the Carpathian Convention (CC). As the consequence, the Memorandum of Cooperation between CC and EUSDR, PA4 was signed at the end of August 2016. PA4 cooperated in solving of common issues (i.e. climate change) and actively participated at CC events (PA4 participation at CC Working Group on Adaptation to Climate Change meeting – Vienna, 27-28/10/2016).

PA4 has put strong emphasison the horizontal cooperation in the level of Pillar B from the very beginning, which includes actors from PA5 and PA6. Within the 5th EUSDR Annual Forum in Bratislava, PA4 organised the workshop "Water – non-alternative source for life" where all the mentioned priority areas presented their relevant projects.

Strong emphasis for cooperation with PA6 is put onsturgeon issues. Tasks are coordinated by PA6 and Sturgeon Task Force. PA4 is also involved in project proposal development of REVISTUR (a basin wide harmonized approach to secure the REVIval of Danube STURgeons) and participated in the project proposal of Danube Sturgeon.

In cooperation with PA5 and other partners (including ICPDR) it participated at the project proposal preparation of Danube Floodplain project.

Furthermore, JOINTISZA project enables cooperation with PA4 in relation to the flood management issues (PA5).

Referring to the previous joint SG meeting with PA7, Priority Area 4 intends to prolong the cooperation, to organise the meetings together, to inform each other about relevant project ideas and ongoing projects and trying to find the common platform for further cooperation. The initiative of wider cooperation among PAs was also initiated by PA6 at the PAC meeting in Brussels in January 2017.

- Provided the information of funding possibilities of the projects and start-ups for SG members and
 provided the platform for discussion on new possibilities on mutual projects preparation at the
 stakeholder meeting held on 21 November 2016 in Bratislava for relevant project partners in
 Slovakia Slovak Technical University, Faculty of Natural Sciences of Comenius University and
 Slovak University of Agriculture.
- Adopted two PA4 relevant strategic projects for financing within the 1st call of Danube Transnational Programme JOINTISZA and DANUBE SEDIMENTS. The projects implementation will contribute significantly not only to fulfilling the PA4 Roadmap actions, but it will strengthen the horizontal synergy, basin wide and sub basin wide activities and cooperation of relevant stakeholders on international and national levels.
- Supported cooperation with non-EU countries Solotvyno, Ukraine outcomes of the scoping and 3 weeks advisory mission.
- Forced cooperation between Water and Agriculture Sectors (Action 6 of Roadmap) organised the international workshop "Trust-building between in the Danube Region" (04/10/2016 in Bratislava). The topic was one of the main "water" topics of Slovak Presidency in EUSDR in 2016 and Slovak Presidency in the Council of the European Union. The goal of the workshop was to build mutual trust, improving relations and strengthening the cooperation between water and agriculture sector. The outcomes were brought to the attention of Water Directors at their meeting in November 2016, with the aim to get a mandate to organize a joint meeting of Water Directors and Agriculture Directors in the spring 2017 resulting to help Water Directors to be informed on the importance of this process.
- Prepared and printed the brochure "What is new in the update of Drinking Water Directive?" which was distributed at the 5th Annual Forum (3-4/11/2016, Bratislava) and 12th PA 4 SG meeting (01/12/2016, Budapest). The workshop topics were in synergy with priorities of SK EUSDR Presidency for water sector and presented the horizontal cooperation of Pillar II Priority areas 4, 5 and 6.
- Co-organization of Budapest Water Summit within which PA4 organised the Stakeholder Seminar (28-30/11/2016, Budapest).
- Dissemination of PA4 achievements continual update of PA4 website <u>www.danubewaterquality.eu</u> and participation at relevant events asSlovak National Participation Day (21/10/2016, Bratislava).

Despite the fact that PA4 regularly informs and disseminates the information on financial possibilities to SG members, orally at SG meetings (12 PA4 SG Meeting), PA4 participates at events organised by ESIF Managing Authorities (DTP) as Seminar held in September in Budapest.

Consequently, during the preparation of PAC financing project for SO4.2 in DTP special call (deadline October 2016), PA4 team actively cooperated and discussed with DTP Joint Secretariat the PA4 working plan for 2017-2019 which was incorporated into PA4 coordination project. Not only the quality of PA4 project proposal, but also the way of PA4 cooperation was highly appreciated by DTP Joint Secretariat.

4.5 LESSONS LEARNED

- Trilateral meetings between ICPDR-EUSDR-Sava Commission facilitated the better harmonisation of tasks among the three organisations.
- Joint SG meetings (especially PA5 and PA7) might have a value of further networking with other priority areas and ease the participation of EC and DSP.
- In case it is possible, PA4 meetings organised back to back with ICPDR core events should be better attended by countries. This initiative is highly respected by the members of the SG.
- If available, PA4 SG meetings should be organised in synergy with other relevant EUSDR events, as the EUSDR Annual Forum, to ease SG members' participation.

4.6 THE FUTURE

- PA4team will continue the good practice of trilateral meetings between ICPDR-EUSDR-Sava Commission, which help more efficient harmonisation of tasks between the three organisations.
- PA4 intends in the future to do its best to involve the countries via SG members to participate at PA4 work plan fulfilling and project generation. In this respect the closer cooperation with NCP is planned. This way of work is intended to be passed to other NCPs as a positive example.
- Dissemination of PA4 outcomes in large conferences and international workshops serve as good practice and should be further considered in the next period as well.
