11:30 - 13:00Plenary session - Energy Security in the Danube Region

> As the end of the decade is approaching, the map of the Central and South-East European supply routes is to undergo profound transformations. As a consequence of the potential downsizing of the Ukrainian transit route, which has been the primary Russian gas supply corridor towards Central and Eastern European gas markets/customers, the region must join efforts to build resilient and well-interconnected gas networks by 2020. For Europe, this underscores the significance of reinforcing energy security through regional cooperation evermore taking into consideration traditional as well as renewable energy sources. Further developing transboundary regional infrastructure projects are the first step towards increasing the energy security of the region. As such the discussions must continue and timely solutions must be found to further urge countries in this region toward a prompt completion of critical infrastructure projects as well as the introduction of regulatory reforms.

## 14:00 – 16:00 Workshop: Regional Energy security (BrahmsRoom)

Within the context of the Energy Union meeting its 2020 goals, this workshop aims to identify recommendations on the policy, infrastructure and market aspects of EUSDR energy markets. It will look into what opportunities the new European-level energy regulations bring to deepening energy cooperation between EUSDR countries, what the future role of Ukraine as a transit country will look like and how this will affect the other Danube Region countries. Finally it will also examine how the existing regulatory and institutional framework can be more harmonized and also look into the question of whether technology can be a good answer to chronic dependency on imported gas.

## 14:00 – 16:00 Workshop: Regional Infrastructure Development (Lehár Room)

A crucial aspect of regional connectivity is showcased also by the ease and quality in which people living in the Danube Region can travel. Significant network planning activities were carried out by the Member states over the past years. The 'Corridor Workplans' define the path for realizing the TEN-T core network corridors until 2030 while the national and regional transport plans provide the necessary frames to anchor these networks together. Indeed the objective, when designing a Corridor, is to create a network capable to connect local traffic flows between themselves and to the international flows, ensuring at the same time a reliable and flexible solution to support economic sustainable growth in the regions. Increasing regional connectivity, especially in the border regions, is also indispensable for economic and social development, which relies on small-scale cross-border infrastructure developments, in which coordinated cooperation is essential.

# 14:00 – 16:00 Workshop: Clean Connectivity (Liszt Room)

The adoption of the 2030 Agenda for Sustainable Development and the Paris Agreement, in parallel with a need to urgently address persistent exceedances of EU air quality standards, has led to a new setting for the energy sector, and changes are inevitable in the transport sector as well. New regulations and technologies are needed to achieve sustainability. This workshop aims to present the perspectives and the potential of clean transportation within the Danube Region with a special focus on the possibility to shift the transport sector towards environmentally friendly fuels. It will look into how the EUSDR countries can contribute to reaching a more sustainable transport sector, whether sufficient infrastructure is currently available to cope with a possible shift, what best practices exist that could be followed and also whether the differences between EU and non-EU countries in terms of clean connectivity can be identified and bridged.


