

The EUSDR Embedding Week got off to a successful start with the first session on sustainable transport, alternative fuels and energy efficiency in the Danube Region.


**DAY 1** | 54 participants | 6 EUSDR stakeholder groups (EC/DG REGIO and EC/DG MOVE, EUSDR core stakeholders, funding institutions, regional/local authorities, transnational institutions, experts/consultants)



In the presentations, it became clear that the transport sector urgently needs investments to ensure its sustainability and that these topics require common strategic frameworks. It also became clear that the different and often individual challenges have to be addressed, primary/secondary resources have to be considered, large-scale has to be distinguished from rather small-scale infrastructure projects, streamlined regulation frameworks would be required and thus new financing models have to be found. This funding cannot come exclusively from the sector itself, but must be cross-sectoral and embedded in the EU's multi-level system, such as combining national grant schemes or the development of a European Greening Fund.

Our speakers invited, representatives of DG REGIO and DG MOVE of the European Commission, the Slovenian

EUSDR Presidency, EUSDR Priority Area 1a (Waterway mobility), Priority Area 1b (Rail-road-air mobility), Priority Area 2 (Sustainable energy), the JS of Interreg VI-B Central Europe and Alpine Space, the MA Interreg VI-A SI-HU, Pro Danube International and TESIM also discussed the better involvement of and funding for accession countries in the Danube Region. The EU-Ukraine Solidarity Lanes, which allow Ukraine to export goods such as agricultural products and at the same time import goods for humanitarian aid or fuel, were highlighted. In addition, relevant studies, projects and agendas - at EU policy, EU funding and Priority Area level - were presented around the thematic focus, taking into account also possible impacts on the environment and biodiversity.




**DAY 2** | 58 participants | 7 EUSDR stakeholder groups (EC/DG REGIO, EUSDR core stakeholders, funding institutions, regional/local authorities, transnational institutions, academia/think tanks, experts/consultants)



The presentations made clear that there is an innovation divide in Europe that needs to be addressed through targeted measures for innovation ecosystems, a deeper coordination and the development of S3 value chains. EUSDR PA 4 and PA 7 also tackle these issues as cross-cutting topics in the overall Danube Region Strategy horizontally in the field of education and youth. This is implemented through planned collaborations in Actions of the EUSDR Action Plans and projects and initiatives included therein, such as joint studies, educational online activities, summer schools and online tools in the mentioned thematic fields.

Our speakers invited, representatives of EC/DG REGIO, the Slovenian EUSDR Presidency, EUSDR Priority Area 4

(Water quality), Priority Area 7 (Knowledge society), the JS of Interreg VI-B Danube Region and Alpine Space Programme, Interact and TESIM also discussed the use of cascade funding for SMEs and transnational funding in the field of cross-sectoral cooperation – not only in the Danube Region, but also in other MRS, such as the Alpine Region. A comprehensive analysis of the themes and financed actions in the 2021-2027 funding framework paves the way for further discussions on which themes are eligible for funding in MRS in the future and what further steps should be taken to ensure targeted funding of MRS thematic priorities. In the end, it became clear that a stronger synchronisation in the implementation of the embedding process in concrete initiatives will be necessary.



- › **Action PA 4: Promote monitoring, prevention and reduction of water pollution** deriving from hazardous and emerging substances (EU priority substances and watch list candidates as well as Danube basin specific pollutants candidates and others e.g. micro plastics-plastics, pharmaceuticals, PFOS)
- › **Action PA 5: Provide sufficient support for development and execution of risk management plans** for different hazards

The session on the third day was dedicated to topics around a greener Danube Region with a focus on freshwater ecosystems, risk management and biodiversity restoration.


**DAY 3** | 56 participants | 8 EUSDR stakeholder groups (EC/DG REGIO, EUSDR core stakeholders, funding institutions, regional/local authorities, transnational institutions, private sector/businesses/SMEs, academia/think tanks, experts/consultants)



In the presentations it became clear that these topics are strongly cross-linked among the Priority Areas and build on long-standing cooperation activities, which will also be continued in the future, for example in the field of water risk management and biodiversity restoration in the Danube Region. In addition, there are new synergy opportunities in the area of the EU Mission in Horizon Europe (Restore our Ocean and Waters). Cooperation with the Danube Region, international organisations, EUSDR member states and institutions is particularly topical in this respect.

Our speakers invited, representing DG REGIO, DG MARE and CINEA of the European Commission, the Slovenian

EUSDR Presidency, the EUSDR Priority Area 4 (Water quality), Priority Area 5 (Environmental risks), Priority Area 6 (Biodiversity and landscapes, quality of air and soils), the JS Interreg Central Europe Programme, Rosinak & Partner together with M&E Factory, EUSAIR Facility Point, Water Europe and TESIM also presented and discussed Embedding matchmaking exercises. Examples in the field of project submission and evaluation, analysis of embedding tools, embedding activities from other MRS and international organisations were presented, showing that implementation will now be crucial to generate actual added value for the Region.



The session on the fourth day focused on a more secure Danube Region, tackling the topic of human trafficking in relation to security enhancement and the building of regional networks.

**DAY 4** | 46 participants | 6 EUSDR stakeholder groups (EC/DG REGIO and EC/DG MOVE, EUSDR core stakeholders, funding institutions, regional/local authorities, transnational institutions, experts/consultants)



In the presentations it became clear that these complex issues, which will continue to challenge the entire Danube Region, concern more than just one Priority Area and are very much interconnected. Moreover, in order to address the challenges of human trafficking, many cross-sectoral factors need to be taken into account and multiple stakeholder groups need to cooperate, particularly as the COVID-19 pandemic has created new challenges due to an advanced digital era. Funding programmes in the Danube Region can provide support, for example, in prevention measures, capacity building for the administration and law enforcement operations in border regions, which complements the jointly planned activities and initiatives of Priority Areas 10 and 11.

Our speakers invited, representing the EC/DG REGIO, the Slovenian EUSDR Presidency, EUSDR Priority Area 10 (Institutional Capacity and Cooperation), also on behalf of EUSDR Priority Area 11 (Security), the MA Romania-Serbia Interreg IPA Programme, the JS Romania-Ukraine Interreg NEXT Programme and TESIM addressed their further needs, such as a network of related projects, gaining data for missing links, and capitalisation of outcomes. In addition, several concrete examples of successfully implemented projects were showcased and future activity proposals were discussed, specifically on the crucial point of trust-building in this thematic field. The programmes present have also embedded the Danube Region Strategy at EUSDR Action level, which allows for targeted funding.




In the presentations, it became clear that these topics, which have gained increased relevance at the European level following the introduction of the European Green Deal (EGD), are now also increasingly implemented in the EUSDR Action Plan by the Priority Areas. By these means, new ways of promoting project development, various participation platforms and promising examples of future initiatives were highlighted.

Our speakers invited, representing DG/REGIO, the Slovenian EUSDR Presidency, URBACT IV, EUSDR Priority Area 3 (Tourism and culture) and Priority Area 9 (People and skills), the JS Interreg Central Europe Programme and Romania-Ukraine Interreg NEXT Programme as well as TESIM shared experiences, challenges and opportunities in funding and implementing urban regeneration in

Policy Objective 4. It became clear that sufficient funding is available, but that cross-sectoral and cross-MRS networks should be deepened in order to fully exploit the potential.

In summary, a very positive and promising conclusion was drawn: The MRS in general, but also the EUSDR in the narrower sense and the Actions of the EUSDR Action Plan in detail are already taken into account in many funding programmes, so that the basis is laid for funding concrete proposals and initiatives of the Priority Areas. Funding programmes and institutions, on the other hand, were able to gain insights into the working methods and thematic activities of the EUSDR Priority Areas and thus get to know new potential beneficiaries – embedding works!
